- 3 Read the following passage carefully and answer the following question : 20

My opposition to prohibition was based on the fact that you cannot improve the morals of a people by legislation. Secondly, it was no business of any Government to tell the people what they should eat and what they should drink. If they drank in a manner that caused harm or was prejudicial to the interest of society, the Indian Penal Code could take care of that. Further, it was conviction that no law should be passed which cannot be enforced. I pointed out that our national motto was that truth must prevail. But we did not for that reason pass laws to force people,

to speak the truth and in my opinion, no prohibition law can ever be successfully enforced. This was established beyond dispute by the experiment that the United States had conducted in imposing prohibition to its citizens. If a man wants to drink, he will drink, law or no law, just as if a man wanted to gamble, he will gamble in game of chance, however rigorous the laws against gambling may be. Further the prohibition law was causing the corruption of the police of the Bar, though fortunately it had not so far touched the judiciary.

He has the capacity to lead the society, mould the society in a positive direction, keep away the society from the many social evils. If one ventures to establish any business, wishes to achieve any goal, he must acquire full knowledge of all the things including his own limitations and weaknesses.

- 5 Reduce the following paragraph into one third and give a suitable title to it: 20

Crude mineral oil comes out of the Earth as a thick brown or black liquid with a strong smell. It is a complex mixture of many different substances, each with its own individual qualities. Most of them are combinations of Hydrogen and Carbon in varying proportions. Such hydrocarbons are also found in other

forms such as bitumen and natural gas. Mineral oil originates from the carcasses of tiny animals and from plants that live in the sea. Over millions of years, these dead creatures form large deposits under sea-bed and ocean currents cover them with a blanket of sand and silt. As this material hardens, it becomes sedimentary rock and effectively shuts out the Oxygen, so preventing the complete decomposition of the marine deposits underneath. The layers of sedimentary rocks become thicker and heavier. Their pressure produces heat, which transforms the tiny carcasses into crude oil in a process that is still going on today.

- (3) 'A' lets a flat on hire to 'B' a smuggler knowing that it would be used for illegal and immoral purpose. Is this valid agreement?
- (4) A man passing by on a road. Upon him there was a fall of barrel of flour from a first floor window. He was injured when the barrel had fallen upon him, he had become unconscious and he was not able to give any evidence how it happened. He claimed for damages.
